The candidate will undertake general economic research, policy analysis, econometric analysis, data development, report-writing, and presentation development on a wide range of projects. The main focus of the project work will be in the areas of aviation (e.g. airports, airlines, air navigation), railways and shippers, marine transport (e.g. carriers, ports, ferries) and tourism.

### **Qualifications**

We are seeking applicants with an undergraduate or Masters level university degree in economics is preferred but we will consider graduates in statistics, mathematics, or business/commerce who demonstrate a strong interest in transportation economics.

The selected candidate must have a strong set of skills in quantitative research and able to both conduct thorough analysis and provide sound interpretations of the results. The Candidate must be able to multi-task, work within a team, work under pressure and deliver accurate results on time and on budget. The Candidate should be motivated by a challenge, committed to achieving goals, and be an analytical and innovative problem-solver. Strong writing skills are your alter ego and you are capable of converting data, empirical results and models into compelling, well-crafted reports for our clients. ### **Key Qualifications:**

- An undergraduate or masters level university degree in economics is preferred, but we will consider graduates in statistics, mathematics, or business/commerce who demonstrate a strong interest in transportation economics.

- Experience in policy analysis and understanding of policy impacts is strongly preferred. This position is not focused exclusively on analytics, and requires knowledge of the policy/regulatory/legislative/institutional settings of the transportation and tourism sectors.
- Advanced competency with MS-Excel or similar spreadsheet applications is a *must have* requirement for this position. Some experience in visual basic or other programming



environment (e.g., SQL, Python) would be an asset. Experience with, and understanding of, statistical software is strongly favoured.

- You are familiar with and excited by current issues in the economy and particularly in the aviation, transportation and tourism industries and can demonstrate continual knowledge building.

**Specific duties will include:**

- Developing detailed knowledge of the aviation, transportation (e.g., rail), tourism and other industries. Our research and analysis approach is not confined to numerical analysis, but rather includes developing deep understanding of the institutional and policy factors affecting our clients' industries and the public interest.
- Analyzing the impacts of policies (and policy changes) in the industry.
- Describing the policy/institutional context of various transportation/tourism initiatives.
